# 2017 annual report nicoalition


### Dear friends,

We push forward because, quite simply, survivors are at the heart of our work and they deserve us to be bold, brave, and tenacious. ## NJCASA continues to serve as a statewide thought-leader on policy and legislation.

In 2017, NJCASA advocacy contributed to:

- Passing of triennial law enforcement training
- New legislation allowing survivors of sexual violence to testify in court via closed-circuit television (CCTV)
- A **full reappropriation of \$4.1M** in the state budget for sexual violence services
- NJCASA experts contributed to the statewide Campus Sexual Assault Task Force Report, which were released in July 2017.



## NJCASA INITIATIVES

Throughout 2017, the NJCASA team created resources, developed and conducted a multitude of trainings, and explored special initiatives, all aiming to support those who serve survivors.



After a competitive grant process, NJCASA was awarded \$100,000 by the Robert Wood Johnson Foundation to conduct a statewide sexual violence needs assessment.



NJCASA staff participated in various statewide working groups, including: the Governor's Advisory Council Against Sexual Violence, Campus Sexual Assault Task Force, NJ Human Trafficking Coalition, NJ-ATSA, among others.




NJCASA staff traveled to the 2017 National Sexual Assault Conference in Dallas, Texas to present nationally on our Social Media Ambassador (SMA) program.

#### NJCASA staff shared their expertise in 60 media pieces throughout 2017, reaching statewide and national outlets.

NJCASA also released its *Media Toolkit* in August 2017, to help better equip reporters covering sexual violence. The toolkit includes an overview of sexual violence, suggested language to use when writing about the issue, and contact information for reporters to reach local experts.
